What you need to do before checking licence application status and viewing the e-licence

- 1. The Authorised Person can check the status of the licence application as well as view the e-licence in eLis upon notification from MOH that the e-licence is ready.

Logging into eLis

1. Go to the eLis website (https://elis.moh.gov.sg/elis/) and click "Login".



- 2. Log in using CorpPass / SingPass
 - a) If you don't have a CorpPass, log in with your SingPass.
 - b) Successful applicants will receive a Unique Entity Number (UEN) to apply for a CorpPass account.
